Dr. Riley Resigns Seminary Position



PRESIDENT RALPH W. RILEY

Dr. Ralph W. Riley, who has served for twelve years as President of the American Baptist Theological Seminary, Nashville, Tennessee, resigns the national position to accept the pastorate of the Hopewell Baptist Church, Newark, New Jersey.

Before coming to Nashville, the Seminary head served as Secretary of the Benefit Board of the National Baptist Convention, U.S.A., Inc.; and Minister of the Dexter Avenue Baptist Church at Montgomery, Alabama. Dr. Riley has had long and wide experience as an educator as well as a churchman and is known and loved throughout the nation. He is a graduate of Morehouse College and Gammon Theological Seminary, Atlanta, Georgia and has done graduate studies at the University of Pittsburgh and Atlanta University. He also holds honorary degrees of D.D. from Selma University and the Ed.D. from Monrovia College, Liberia, Africa. He is listed in Who's Who in the South and Southwest and a member of three national learned societies and fraternities; among those are: Kappa Delta Pi and Sigma Rho Sigma societies and the Omega Psi Phi fraternity.

Since Dr. Riley's coming to the Seminary, the school has grown in facilities, increased student body as well as prestige in educational and religious circles to a noticeable and significant degree. The physical plant has grown from one to five modern buildings, with thirteen faculty and student homes, a student body from 44 to 129, with extension units in five states, and alumni in 29 states, Africa and the West Indies.

The Church which will be served by Dr. Riley is one of the largest and most historic in the East, and Dr. Riley's ex-

perience as an educator, imminent pulpiteer and scholar not only fit him to serve Hopewell Church, but the entire New England area. In a most significant and constructive way as a national leader in religious and denominational circles, Dr. Riley has allied himself in many ways with the larger interest in the community, and his leaving will be a blow not only to the Nashville public, but the State and the South as well.

Dr. Riley is a member of the AGORA National Assembly, Prince Hall No. 1 Masonic Lodge and a 32° Mason; Pride of Tennessee Lodge 1102; member of the Board of Directors and chairman of the Building Committee of Eighteenth Avenue Community Center; director of Universal Life Insurance Company of Memphis, Tennessee; Nashville Sportsmen's Club; the Jones Valley Finance Corporation; Advisory Council of the American Christian Palestine Committee, New York City, and has travelled over a period of years in Europe, South America, the near East, Africa and the West Indies.

It is understood that Dr. Riley will take up his new duties on or about June 1, but before leaving, he will fill many engagements in the South. He will preach the Baccalaureate sermon at Alabama A. and M. College, Normal, Alabama, and will deliver the Commencement address to the graduating class of the Seminary during its thirty-second Commencement at the Seminary, May 28, 1956, 8:00 P.M. in the J. B. Lawrence Administration Building.

Dr. Victor T. Glass Accepts Seminary Post

Dr. Victor T. Glass has accepted the position of Acting-President of the American Baptist Theological Seminary, Nashville, Tennessee, effective June 1, 1956. In the interim Dr. Glass will work in collaboration with President Riley in closing the present school term and working on plans for the 1956-57 term.

He has been with the Seminary since 1946 as professor of New Testament and Christian Ethics. In 1952 he was elected Academic Dean. He is a member of the Board of Directors of the Eighteenth Avenue Community Center and other civic and religious organizations in the city of Nashville.

Dr. Glass is a native North Carolinian. He is a graduate of Carson-Newman College, Jefferson City, Tennessee and holds the master and doctorate of theology degrees from the Southern Baptist Theological Seminary, Louisville, Kentucky.

Dr. Glass is married to the former Edith Messer of Waynesville, North Carolina and has two sons, age 14 and 10.



The General Baptist Convention of Florida met in Gainesville, April 3-8, 1956. Rev. J. A. F. Finnlayson, President of the General Convention, Mrs. Susie Hollie, President of the Woman's Convention, Rev. George O. Sumner, President of the Sunday School Congress, and Mrs. Tempie Ford, Director of Young People.

The meeting was well attended. Excellent sermons were preached by ministers like Dr. A. B. Coleman, of Jacksonville, Florida. Rev. C. K. Steele had charge of the devotion for General Convention. The meeting in general was inspirational and informative.

The women had a banner session led by Mrs. Hollie. More than \$10,000 was raised by the women for Florida Normal, an Industrial School. Dr. R. W. Puryear is president of Florida Normal.

The young people sponsored a Pantry Shower, also a Linen Shower. Both affairs were a huge success.

The President of the school reported progress was being made. Larger sums were coming in monthly.

Dr. Nannie H. Burroughs, President of the Woman's Auxiliary of the National Baptist Convention, was guest speaker. This meeting was held in the High School auditorium. More than 3,000 persons were present, and a delicious banquet was served by the school teachers at the close of the meeting.

Other guests present were Mrs. Esther Tyree, Corresponding Secretary, Mrs. C. M. Pierson, President of Georgia Baptist Woman's Convention, and Chairman of Life Membership Committee, Dr. Roland Smith, Secretary of the B.T.U. Board, Rev. M. Did You Pray


Yes, I thought of you this morning

Integrity means recognizing one's own responsibility. It means shouldering the blame which is one's own instead of trying to push it off on somebody else.

Integrity means disciplining one's desires, never letting them tyrannize your best self.

Integrity means setting up for yourself a standard of intellectual as well as financial honesty and seeking day by day through the grace of God to live in accordance with these standards.

Integrity means accepting the fact that you are your brother's keeper and bearing his burden so that you may fulfill the law of Christ.

Jesus said, "Be thou made whole!" Through the grace of God in the forgiveness of our sins for Christ's sake as we accept his mercy we can be made whole. Then life will be filled with integrity.




